Bird Barrier Bond is a UV stable adhesive/sealant with a high initial tack; it provides significant grab in 30 minutes. Full cure is 24-48 hours, but faster when pressed into a thin application. Excellent for clean porous and non porous surfaces. It can be used for high strength bonding of a wide range of applications. When cured, the Bond is a flexible, elastic rubber that won't crack or break. Bird Barrier Bond cures by drawing moisture from the atmosphere so it is "green", it is free of isocyanates, solvents, halogens and acids. VOC Compliant.

#### DIRECTIONS

1. Surface must be clean, dry and free of dirt.
2. Cut end of nozzle to desired opening size. Puncture foil seal and use a caulking gun dispenser to apply the adhesive. Apply as per Bird Barrier's recommendations (see photos to the right). Press the product firmly to the surface.
3. Recommended application temperature is between 40°F and 90°F. Cure time increases in lower temperatures. The bond will provide significant "grab" in 30 minutes. Complete cure requires 24-48 hours.

**Clean-Up:** Use a wet, soapy sponge or cloth to clean up uncured adhesive. Cured material may be removed by cutting or scraping.
