DIRECTIONS FOR USE: For Landscaped Areas: Using the scoop provided, spread Iguana ScramTM Professional by hand inside the landscaped areas so it is visibly heavy enough to see. One scoop should cover 10 square feet. Also apply as a 18-inch barrier around the outside of the landscaped area. For Trees and Shrubs: Sprinkle around shrub bases to keep iguana's from climbing to get to vegetation. Apply a 24-inch barrier around trees or shrubs starting at the drip line. This will keep them away from the leaves. For Excessive iguana problems in areas: Apply a second band 15 inches out from the first strip around the bed & sprinkle Iguana Scram Pro lightly throughout the inside of the bed. This will stop the problem & only a single band nearest the bed will be needed for maintenance.
